I am aware that this document also serves as the formal deregistration letter if the debt is not settled by March 1, 2019, and that there will be no other notification of deregistration to be issued.

Deregistration means that I will not be able to undertake any work on this said semester and work already submitted might not be marked but congruently removed from the Marker's roster. The decision to mark any work that was already submitted will be solely dependent on the amount I deposited and if the same can cover the cost of the work already submitted plus the interest or fee that might have been incurred from the breach of this 30-day Promissory Note To Pay.
